## **Hardenhuish School**

### **Uniform Policy**

The School uniform is important because it generates a sense of belonging and purpose, and those wearing it - Hardenhuish pupils - show an acceptance of the order and conformity needed to attain the school's high standards. Pupils represent themselves and us outside of school and are expected to maintain high standards whenever and wherever the uniform is worn, including travelling to and from school. Pupils have a responsibility to comply with this Uniform Policy. All staff are responsible for monitoring uniform and intervening should that prove necessary (see Conduct Card Guidance). The wearing of school uniform does not apply to years 12 and 13 though a dress code is in place.

School sweaters, ties and some items of PE kit as listed below are only available from the school's nominated uniform supplier. Items of uniform are kept at the school so pupils can try them on to ensure they purchase the correct size,

All garments must be clearly marked with the pupil's name.

**The following items of uniform and P.E. kit can ONLY be purchased from the school's nominated uniform supplier.**

TIE	Green with school logo
SWEATER	Green with gold stripe and school logo
SHORTS (optional)	Black tailored knee length

Green and black winter shirt with gold piping and logo  
Green and black polo shirt with gold piping and logo (Unisex or girl fit)  
Green and black shorts or skort with gold piping  
Green and black hooped socks  
Black fleece or jacket with green piping and logo (Unisex or 'Girl fit') *optional*

**The following items of uniform can be purchased from a dedicated school uniform supplier or from the schoolwear (and not fashion) range of only those retailers who offer a specific schoolwear range of clothing e.g. Asda, John Lewis, Marks & Spencer, Sainsbury, Tesco, etc.**

SHIRT/BLOUSE	White, button to neck with either short or long sleeves (not $\frac{3}{4}$ length), button-free collar, one pocket maximum
TROUSERS	Black, tailored
SKIRT	Black, tailored (below fingertip length when arms are at the side of the legs)
SHORTS	Black, tailored, knee length shorts. These must be purchased from the school's uniform supplier.
SHOES	Black, suitable for walking around our campus. (Trainers, shoes made of canvas and other non-waterproof materials are not acceptable.)
SOCKS	Black or white
TIGHTS	Black
COAT	Weatherproof (Denim coats, fleeces and sweatshirt garments are not acceptable.)

## **P.E. /GAMES KIT & EQUIPMENT**

Sports trainers  
White socks (summer sports)  
Rugby/football/hockey boots with studs or blades  
Shin pads  
Gum shield (advisable)  
Black base layer top *optional (short or long sleeved)*  
Black footless long base layer bottoms *optional*  
Black, plain tracksuit bottoms *optional*

## **DANCE**

### **Year 7**

P.E. kit. Black plain tracksuit bottoms or black plain jazz pants may be worn instead of shorts or skirt.

### **Years 9-13**

Fitted black T shirt, plain or with Hardenhuish Dance logo. Black plain tracksuit bottoms or black plain jazz pants.

### Other expectations:

1. *Shirts or blouses must always be tucked in, the top button fastened and ties worn to cover all buttons. Vests or t-shirts worn under the shirt or blouse for warmth must be plain white.*
2. *Belts, if worn, should be plain, black or dark brown and threaded through trouser or skirt belt-loops.*
3. *Haircuts and styles should not be extreme and should conform to the Health and Safety requirements of practical lessons. Any changes to hair colour should be of a natural shade and distributed in a natural manner. Pupils are encouraged to speak with their Pastoral Manager **before** styling or colouring their hair to clarify acceptability.*
4. *Jewellery...pupils may wear a watch; they may also wear a single small stud/sleeper in one or both ears, other body piercings are not acceptable.*
5. *Visible make-up should not be worn, this includes nail varnish.*
6. *Black boots, suitable for walking around our campus are acceptable. Boots made of canvas and other non-waterproof materials are not acceptable.*
7. *A school bag must be backpack style (twin shoulder straps) and be large enough to accommodate an A4 folder.*
8. *Suitable protective apron for practical Food lessons*
9. *All garments which may be removed should be clearly marked with the pupil's name*

These expectations are displayed in every classroom in the school (See Appendix 1). Breaches of uniform expectations will be dealt with in line with the Conduct Card Guidance (see Positive Behaviour Policy). Learning Managers and a designated member of the Senior Leadership Team will be the arbiters of the application of this policy.

While we will make every effort to accommodate religious clothing, the needs of safety, security and effective learning take precedence. Our suppliers have access to a limited range of religious clothing, in school colours. Parents are welcome to approach the school in such circumstances.

APPENDIX 1: UNIFORM EXPECTATIONS POSTER

**HARDENHUIJSH SCHOOL UNIFORM EXPECTATIONS**

**Earrings:** One pair of small sleeper or stud earrings may be worn (one in each ear). These must be removed for PE lessons. Therefore new ear piercings should only be done at the start of the Summer Holidays.

**Sweaters:** Hardenhuish green with gold stripe and school logo. Only available from the school's Uniform Shop. These are compulsory between October 1st and May 1st but optional at other times.

**Shirts/Blouses:** White, buttoned to neck, long or short sleeved shirt or blouse (no three quarter length sleeves). Maximum of one pocket. These must be tucked into trousers/skirts at all times except lunchtime. Plain white vests or t-shirts can be worn underneath shirts for extra warmth.

**Skirts:** Black, tailored skirts. With regard to skirt length, when a pupil stands upright and places their hands by their sides, with their arms straight, the skirt should be longer than their fingertips.

**Shoes:** Black shoes that are suitable for walking around campus. No trainers, canvas shoes or shoes of other non-waterproof material are allowed. Laces should be black. Alternatively, black boots may be worn but these should be plain and can not be made of canvas or other non-waterproof materials.

*All garments that might be removed should be clearly marked with the pupil's name. Hardenhuish specific uniform (sweaters, shorts and ties) are only available through the school's Uniform Shop (see the school website for more information about the shop and about our PE Kit requirements). A limited supply of religious clothing in school colours may be available from the school. While we will make every effort to accommodate religious clothing, the needs of safety, security and effective learning takes precedence.*



**Coats:** Coats must be weatherproof and must be removed during lessons.

Denim coats, fleeces and sweatshirt garments (including 'hoodies') are not allowed.

**Ties:** Green tie with school logo available from school's Uniform Shop. Black Prefect Ties may be worn by Prefects.

This should be worn to cover all visible buttons (maximum of one button showing at bottom when sweaters are not compulsory).

**Trousers:** Black, tailored trousers (not drainpipe/tight style). No denim.

Belts, if worn, must be plain, black or dark brown and threaded through trouser loops.

**Shorts:** Black, tailored, knee length shorts. These must be purchased from the school's Uniform Shop.

**Socks or Tights:** Socks can be black or white. Tights must be black.

**The following are not allowed in school:**

- Ø Unnatural hair colours or 'extreme' hairstyles and hairstyles that do not conform with the health and safety requirements of practical lessons.
- Ø Visible make-up (including coloured fake nails, nail varnish or body art).
- Ø Jewellery (including rings, bracelets, necklaces).
- Ø Additional earrings or any other kind of piercings.
- Ø School bags that are not 'backpack style' (with twin shoulder straps) or are too small to hold an A4 folder.
- Ø Mobile technology (e.g. phones), which are visible and switched on during the school day (see guidance in policy).
